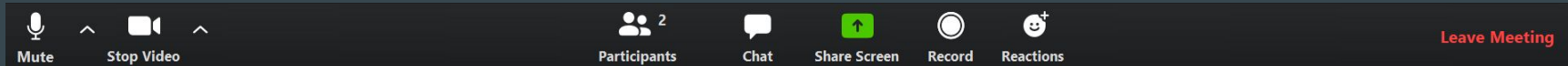

Our Purpose

Design an inclusive and comprehensive Washington strategy with families, communities and child welfare system partners to keep babies and their families experiencing challenges healthy, safe and well.

Principles - Must Do

Actively engage parents, caregivers and communities

- Infuse parent voice - mothers and fathers - in design and implementation
- Empower parents and earn their trust

Equity and Inclusivity

- Address disproportionality across race and socio-economic status
- Ensure tribal participation

Collaborate across silos

- Operate in strength-based and respectful manner
- Commit to continuously learning and improving

Principles - Must Do

Prevent removal whenever possible

Keep sustainability front and center

Ensure sufficient, meaningful services

- Enable rural and remote communities to participate in SBCT
- Support community providers to deliver services

Messaging

- Have clear, strong messaging to support program viability
- Keep champions informed to build momentum and support

Principles - Must Not Do

Take a top-down approach

Ignore local and cultural differences

Allow conflict to derail collaboration

Duplicate other efforts

Shame parents

Exclude fathers

View substance abuse or homeless as challenges that cannot be overcome

Funding Opportunities

1. Legislative “asks”
2. HRSA opportunity: ZTT will release a RFP to subcontract for one year to fund the following:
 - a. States - minimum of 3 sites per state
 - b. Site expansion - must serve 2 full dockets
 - c. Capacity building - align with the SBCT approach
