Data Overview

- 42% of child abuse and neglect cases in WA were for children under 3
- Of all children who go into care, 25.6% are infants under 1. The second highest rate in the county
- Disproportionate child welfare involvement among American Indian/Alaska Native (AI/AN) and Black children aged 0-2
 - Even though the total filings in COVID have gone down, young children are still the largest group coming into care
- Data and Evaluation Advisory Group
 - Provide guidance and professional advice about program design, development of program indicators and measures of success

Background and Accomplishments

- CCYJ was approached by ZZT to expand baby courts in Washington State
- CCYJ worked with statewide stakeholder to develop a plan to expand the number of courts and develop a statewide structure
- Addressing racial disproportionality and safe family reunification
- Sites:
 - Kitsap County

- Spokane County
- Thurston County
- Pierce County
- Clark County
- Funding has been extended through September 2022 and a new funding opportunity to be released in Feb 2022
- WA state legislature created new funding stream for AOC
- SB 5331 Codifies Standardization of Early Childhood Court Programs
- Two Key components: Early Childhood Courts and Systems Change Initiative
 - This group will focus on systems change initiatives
- Role of SAB
 - Identify key statewide priorities
 - Provide high level strategy
 - Champion for ECC programs
 - Center equity
