





2023 ENROLLMENTS**





STEERING COMMITTEE GOALS SNAPSHOT

** In January, 2024, a reorganization of the MDIT structure, reduced the number of MDIT tables to 2: Youth LINC A - comprised of the Seattle, Renton, Burien, and Tukwila areas and Youth LINC B - comprised of the Auburn, Federal Way, and Kent areas.

The activity records of those clients who were still enrolled on January 1, 2024, were reassigned to the new table designation. Records of clients who exited the LINC program by December 31, 2023, retained the former table designations: Seattle LINC, Youth LINC 1, or Youth LINC 2. As such, data presented in charts in this 2023 Snapshot reflect the accurate client counts as designated by their assigned table name in our database depending on their enrollment status at the end of 2023. No one is counted twice.

Starting in January, 2024, all clients will be assigned to one of two tables: Youth LINC A or Youth LINC B.
