CCYJ'S FAMILY ADVOCACY CENTER OPENED DOORS IN EARLY 2016. IT IS A SOUTH KING COUNTY BASED REPLICATION OF THE DETROIT CENTER FOR FAMILY ADVOCACY, WHICH WAS LAUNCHED BY THE UNIVERSITY OF MICHIGAN LAW SCHOOL IN 2009. THE MODEL PROVIDES CIVIL LEGAL REPRESENTATION AND, IF NEEDED, SOCIAL WORK SERVICES, AND PARENT ALLY SUPPORTS TO FAMILIES TO PREVENT THE UNNECESSARY PLACEMENT OR PROLONGED STAY OF CHILDREN IN FOSTER CARE.
